Snippets from your Ward Councillor

It was an incredible honour and privilege to be elected councillor for Congresbury and Puxton on 2nd May. Now that the hard work has started.

Immediately after the election, as no one party had a majority, the political groups discussed how to form an administration to ensure that the Council continued to function. As the Conservatives declared on 3rd May that they would go into opposition in view of the election result, the other political groups have formed a "rainbow administration" sharing executive posts proportionately. Since 14th May councillors have been familiarising themselves with their briefs and putting together policies.

Perhaps the two most significant/contentious issues at the moment are the Joint Spatial Plan (in which the Churchill garden village is proposed) and the Airport expansion. The Joint Spatial Plan was submitted to the planning inspectorate in April 2018. Hearings by the planning inspector commence on 2nd July. I attended a very helpful meeting with the Churchill and Langford Residents Action Group. Business West also attended and expressed their concerns that the transportation rationale and sustainability of the garden villages were not adequately support by the evidence presented. Accordingly, there may be a more than negligible chance that the planning inspector will find the Joint Spatial Plan to be unsound. The councillor for Blagdon and Churchill (Patrick Keating) and I have been urging other councillors to read into the Joint Spatial Plan with a view to exploring policy in this regard.

At a briefing on 4th June, council planning officers explained that they are still preparing their advice on the Bristol Airport expansion application. They expect to be able to provide this advice in time for the Planning and Regulatory committee to vote on the application in September.

I have been appointed to the Planning and Regulatory Committee and attended my first meeting on 19th June.

I very much look forward to working with Congresbury Parish Council over the next four years to achieve as much as possible for Congresbury and its residents.

New Village Hall-Public Works Loan Survey Result

One of the ways that money can be raised for Local Projects is for the Parish Council to take out a 'Public Works Loan'. Money to repay the loan would be raised as an additional precept and added to the Council Tax paid by each house in the Parish.

The recent poll initiated by the Congresbury Village Hall Limited in conjunction with the Parish Council only received a response from approximately 28% of households. Of those 64% (266) did not support the Parish Council taking out a loan. With the majority who took part in the poll rejecting the proposal, the Parish Council has accepted that a Public Works Loan is currently not an option to partly fund a new community building.

Consecration of the Burial

Ground

Having been present when the upper section of the Parish Council Burial Ground was 'Consecrated' in 1982, I well remember it was raining. The late Derrick Holmes a former Chairman of the Parish Council and I were sheltering in the shed! It was raining on Thursday 25th April 2019 when the lower section of the Burial Ground was consecrated and the Bishop had to be protected with an umbrella.



In an ancient ceremony conducted by one of the Assistant Bishops of Bath and Wells, the remaining section of the Burial Ground was duly consecrated. A small section being left for Villagers who don't wish to be buried in consecrated ground.

The ceremony began with Cllr Diana Hassan the Chairman of Congresbury Parish Council, reading a petition on behalf of the Parish Council to the Rt Revd George Cassidy asking him to consecrate the land. The Bishop duly responds and conducts the service and

leads the gathering in prayer assisted by Revd Matt Thomson. Janet Saxon the Deputy Registrar of Bath and Wells, in 'Wig and Gown' reads the official authorisation and the ceremony ends with the land being blessed.


to help the new village hall fund. Customers are asked to please bring their own bags.

Howzat! Cricket Book Captures 175 Years of **Village Life**

A new book celebrating 175 years of village cricket opens up a window on life in North Somerset through the Victorian and Edwardian eras to the present day. The book, published by the Cricket Club in association with the History Group, tells much more than the story of cricket in the village over the generations.



The more research I did. the more people I spoke to, the more I realised how the fabric of village life and the development of cricket were intertwined," said local historian and author Clive Burlton. The book, with 112 pages, 60,000 words and 250 images draws on the archives held by both the cricket club and the history group as well as

recounting the memories of villagers and players, past and present.

Clive, a club vice president, explained: "Among the many nuggets we've found is a photograph and an account of a 1907 men v women cricket match in the village with men batting left-handed with broomsticks! "We also found recipes for all sorts of cakes and pies written by village ladies with known links to cricketers of the time which sparked the idea for a cricket tea bakeoff at the Congresbury Village Fete on June 29."

The oldest document uncovered is the scorebook from 1919. The first match after World War One was against Weston-super-Mare. The two clubs met again in April this year in a pre-season friendly almost 100 years later. The book tells far more than the story of Congresbury CC and looks at the development of cricket in North Somerset from the middle of the 19th century with extensive use of newspaper archives since the 1840s.

175 Years of Village Cricket is available from Day Lewis Pharmacy, the Post Office and the Recreation Club.

Neighbourhood **Development Plan**

The Congresbury Neighbourhood Plan has been through independent Examination and North Somerset Council have formally agreed that the Plan meets the necessary basic conditions and other provisions in order to go forward to referendum. The referendum date will take place on 19th September 2019 in the Old School Rooms, Congresbury.

The Examiner has concluded that a number of modifications were required and a number of these modifications were significant namely:

- Deleting the proposed limit of 150 dwellings during the plan period.
- Removing the policy that prevents new housing development coming forward adjacent to the settlement boundary.
- Deleting the proposed amended settlement boundary.
- Deleting the requirement for housing sites to be no more than 25 dwellings.
- Amending the affordable housing requirement to reflect the Core Strategy.
- Changing the Area of Separation to an Area of High Landscape Sensitivity and designating a smaller area on the plan.
- Repositioning a number of policies as Community Actions.

The Neighbourhood Plan Steering Group urges all parishioners to vote for the Plan as it will have benefits to the parish. Further details will be available soon with regard to the revised plan.
