- d) 25/P/0451/FUL Somerset Court Stock Lane Langford Congresbury BS49 5JL Section 73 application to vary condition 2 (plans) attached to planning permission 21/P/1349/FUL (change of Use from B1 office to 3no. dwellinghouses with two storey rear extension) to allow for slight increase in ridge height of front elevation facing road, rooflight positions and sizes and window/door arrangements to unit 3, west elevation gable treatment changed to a full elevation of natural stone in place of cladding.
