Minutes of the Full Council meeting of Congresbury Parish Council, held at the Old School Rooms, Congresbury on Monday 14th August 2023 at 7.30pm

23000 **Public Participation**

A resident of West Mill described the problems caused by obstructive parking in Mill Lane, Mill Leg, St Congars Way and West Mill for recycling and emergency vehicles. He suggested planters may be the way forward as parking restrictions cannot be monitored all of the time. A resident explained his concerns regarding the Environment Agency plans for the Millennium Green. Alternative plans needed to considered including moving the Youth Club.

Cllr D Thomas (NS Councillor) reported it had been a quiet month he had been looking at the several projects including the bus service improvement plan, Millennium Green and Brinsea Batch.

23004. **Clerks Report**

King George V Play equipment – After several months the play equipment has finally been completed.

The Kent Road Green has been reinstated and I have informed our contractor that will need to cut the grass.

The Environment Agency will be carrying out maintenance works to the Congresbury Weir, footbridge and bank repairs starting in September and lasting 4-6 weeks.

From September 4th the X5 service will re-route through Yatton, timetables are available Due to misuse the noise complaint telephone line at Bristol Airport has been closed and a postal process introduced. The online noise complaint portal remains the same.



North Somerset Council has sent information of a tree planting scheme taking place over the next two years. They may be able to help with funding and would be happy to hear of any tree planting schemes or projects.

I have been contacted by North Somerset Council who has asked if they could attend our next Full Council meeting to discuss the bus service improvement scheme for Smallway and Woodhill.

Electoral Registration Officers (EROs) are required by law to conduct an annual canvass on all residential properties in their area. North Somerset Council has provided a guide for Parish Councils

The clerk has received the resignation of Cllr Chris Beyfus, North Somerset Council have been informed

The new website went live on Monday 7th August 2023.

After months of correspondence with the banks the Corporate Credit Card has been reactivated

Recreation Club (Project Construct) I have had an email asking about the possibility of the Parish Council taking out a PWLB to help with construction costs. To be discussed on the next Full Council agenda
