### 23013 **Public Participation**

A member of the public raised concerns over the Bus Service Improvement Plans at Woodhill and Smallway. Are the plans set in stone, is there going to be a public consultation and will local people's views be taken into account.

A resident of Brinsea Road expressed his concern following the accident near The Elms on Monday and the speed of the traffic on the road.

A resident of Kent Road stated that since the bench near the bin had been removed, the anti -social behaviour had moved to Editorial Bench which is opposite his property and he asked that when the bench is removed it is not replaced.

Burial Ground – I have received several complaints about the state of the burial ground. Cat and I met with the contractors and explained the issues. The Clerk had also agreed, following a quote, a contractor to tidy up the Yew Trees as they have elder and large brambles growing out of them which pose a health and safety issue.

**Full Council Minutes** 1 of 3 11<sup>th</sup> September 2023 Congresbury Football Club – Have asked if we could resurface the remaining part of The Drove as it is full of potholes. NSC has checked the Land Registry and this part of The Drove is unregistered and it is not on our deeds.

We have a new electricity/gas supplier - ENGIE

The allotment shed (which is an asset of the Parish Council) has had several attempted break ins. The allotment holders use it to store mowers/rotivators. As the Council no longer use the shed would it be acceptable to donate the shed to the allotment holders association and they would then be responsible for the shed. To be discussed at the next Full Council The clerk has received the resignation of Cllr Geoff Underwood, North Somerset Council have been informed

Last week I received a visit from Nick Gough the PSCO for Congresbury and Keith Millard Police Support Volunteer. They asked and spoke about problems in Congresbury. He hopes to be able to attend Council meetings in the future.

I have been asked by Weston Town Council if we would grant permission for the Mayor of WSM to wear his chains of office in our parish at an evening event on 20.10.2023 – No objections to the Mayor wearing his chains of office.

### 23018 Kent Road Green – Benches

The Clerk informed the Council that the Chairman Cllr Jane Clarke had spoken to the resident who complained about the original bench and his opinion remains unchanged he does not wish the new bench to be replaced close to his property. In light of this information and the resident not wishing the editorial bench replaced. It was suggested that the anti-social behaviour is monitored following the removal of the bench and see if the Council receives any feedback.
