**23059 Minutes of the previous meeting**  
The minutes of the Planning Committee held on 18th December 2023 were agreed and signed.

**23060 To consider the following planning applications:**  
a) 23/P/2704/ADV - Star Inn Rhodyate Hill Bristol BS49 5AJ - Retrospective advertisement application for the replacement of existing signage with new; 2no. hanging signs and 3no. Lanterns to the South-East elevation (02A/02B and 08A/08B/08C) and the Primary and secondary panels on existing post to the South elevation (01/01B). Removal of 1no. Raised panel at the South-East elevation and relocation to the East elevation with new Panels (03B). Installation of new signage including 2no. Directional panels and 1no. Fence mounted Panel at the South-West elevation (10A/10B and 03A) alongside multiple painted/printed logos and welcome signs to all elevations with externally mounted illumination (05/07/17/14/14A).

**Resolved** – That the Planning committee noted this planning application.  
b) 23/P/2795/FUH - Brinsea Road Farm Brinsea Batch Congresbury BS49 5JP- Proposed erection of boundary fencing/gates for each unit and 2no.Canopy porches to the East elevation of Unit 1, and South-West elevation of Unit 2. Fenestration alterations including the removal and installation of doors and windows.

**Resolved** – That the Planning committee recommends approval of this planning application.

c) 23/P/2834/FUH - 2 Church Farm Station Road Congresbury BS49 5DX Proposed demolition of existing conservatory and erection of single storey extension in place

**Resolved** – That the Planning committee recommends approval of this planning application.

d) 23/P/2832/ELE - Land South Of Cobthorn Way Wrington Lane Congresbury North Somerset - Notification of National Grid Electricity Distribution PLC intension to remove an existing overhead line and place it underground along the length of circuit between Land on the south side of Cobthorn Way, Congresbury (Title No. ST167797) and Land lying to the south of Iwood Farm, Wrington (Title No. ST278391). The undergrounding proposed is approximately 1.1km in length and joins existing terminal poles.

e) 23/P/2852/FUL - Existing Agricultural Building Wrington Hill Wrington Congresbury - Removal of condition 2 of planning permission 99/0102 (retention of alterations and extensions to ex-shooting lodge)

f) 24/P/0036/TRCA - Challacombe 5 Pauls Causeway Congresbury BS49 5DH - Leylandii (T1) - Crown reduction by up 2mtrs to side only over neighbours boundary


