2457 Precept 2025/26

RFO provided details of the precept submission sent to North Somerset Council (NSC). **Resolved:** All Cllrs noted the precept amount requested and electronic submission, within the allocated time, along with response from NSC to confirm receipt.

2458 Budget 2024/25

RFO provided the annual budget to show income and expenditure as at 31st December 2024. RFO provided update of meeting held at the Parish Office in December '24 with a Congresbury Community Library representative regarding ongoing matters.



Resolved: Following the Full Council meeting in January 2025, The Old School Rooms window refurbishment will be financed using general reserves. Cllr Razzell proposed, Cllr Holland seconded, and all Cllrs agreed.

Recommended: RFO to contact Library representative for an update of actions required before 31st March 2025. Congresbury Parish Council to obtain Insurance quotations from April 2025.

2459 Millennium Green Trust

Members reviewed bank accounts and considered a 5-year plan.

Resolved: 5-year plan noted. Risk assessment to be taken to next Millennium Green Committee meeting for update. NatWest account to be closed and all money to be placed in Congresbury Parish Council account and held in Millennium Green Trust earmarked reserve. Virgin Money account to continue with a small amount retained to keep account open, all remaining money to also be placed in Congresbury Parish Council account held in Millennium Green Trust earmarked reserve. Clir Holland proposed, Clir Hill seconded all Clirs agreed.

2460 Consideration of additional Bank account(s)

RFO provided an explanation of action(s) taken following the December Finance Committee meeting and produced a report following an online teams meeting held with CCLA, to inform Clrs about the Public Sector Deposit Fund (PSDF).

Resolved: 30% of precept to be invested as per CPC Investment Strategy to hold on contingency. The agenda item regarding CCLA will be on the next Full Council meeting. Cllr Holland proposed, Cllr Razzell seconded all Cllrs agreed.

Recommended: RFO asked to approach additional Building Society to seek further information and clarification of services they provide. Any further responses received to be shared at the next Finance meeting. All ClIrs agreed.

2461 Online booking or card payment system

Members asked to consider the potential set up implications, functionality and running cost(s)/booking fee(s) of online booking or card payment systems, for the Old School Rooms (OSR) via the Parish Website.

Recommended – Current booking system is dated and not suitable to use online. Having reviewed the functionality requirements, an online booking system would be considered practical and cost effective, to be investigated further. All Clirs agreed.
