24060 Proposed Solar Farms at Oldbridge - (West of Congresbury) and Strawberry Solar Farm (West of Brinsea Road)

- Prior approval for the conversion of agricultural buildings and area of land immediately surrounding the buildings to 1no. residential dwellinghouse (Use Class C3)

with operational development including rendering of walls, insertion of new windows and doors

b) [25/P/0301/FUL](#) - Cadbury Garden and Leisure Smallway Congresbury BS49 5AA - Change of Use from Garden Centre storage area to Car Wash (Sui Generis) and erection of an office building with decking area, 2no. parasols for drying area and 1.8m high polycarbonate screening to washing bay

Resolved – That the Planning committee recommends refusal of this planning application. There are already several car washes in the area and it would be urbanising the garden centre.

c) [25/P/0445/LDP](#) - Middlecombe Nursery Wrigton Road BS49 5AN – Certificate of lawful development of 4no. temporary moveable outbuildings /workshops for arts and crafts businesses to operate in grounds of existing plant nursery business.

d) [25/P/0451/FUL](#) - Somerset Court Stock Lane Langford Congresbury BS49 5JL - Section 73 application to vary condition 2 (plans) attached to planning permission 21/P/1349/FUL (change of Use from B1 office to 3no. dwellinghouses with two storey rear extension) to allow for slight increase in ridge height of front elevation facing road, rooflight positions and sizes and window/door arrangements to unit 3, west elevation gable treatment changed to a full elevation of natural stone in place of cladding.
