The new gas pipe on the A370 Station Road should have been started last Tuesday and have taken about six weeks. I have not been informed why it was postponed or when it will start again.

As mentioned in public participation a resident has asked to replace the bench by the traffic lights in memory of his daughter. Cat and I looked at the bench and it is showing signs of wear. An agenda item for next month.

Planning application has been sent to North Somerset Council for the solar farm on the land to the west and east of the Strawberry Line, Brinsea Road, Congresbury – comments need to be made to NSC by 29th May 2025. This will be discussed at the next planning meeting Monday 19th May 2025. The plan application for the solar farm at Oldbridge have not yet been received by North Somerset Council but are imminent.

North Somerset Council are inviting residents, businesses, councillors and anyone interested in the future of public transport to the bus user's forum 2025. Two sessions are offered Monday 19 May online and Wednesday 21st May in person details are on our website. Attendance is free but you must register in advance.

DCK Accounting Solutions will be closing the 2024/2025 accounts on Friday 16th May and the internal auditor will be completing her third visit of 2024/2025 and finalising her AIAR report (Annual Internal Audit Report).

An allotment holder has complained that she is paying too much for her allotment as it is not as big as other full plots. An agenda item for next month.

The antisocial behaviour by Homefield/Cadbury Square has been reported to the police. The bin has gone missing on the junction of A370/B3133 by the Geoffrey Peacock Garden sometime between Friday 2nd May and Saturday 3rd May. The bin belongs to North Somerset Council I have reported it to the Waste & Cleansing Contracts Manager; he is going to arrange for a replacement.

The plans for the signage, lights and camera, in the car park, at the Congresbury Arms have been approved by North Somerset Council.
