#### 2136 Grants 2023/24

The following grant applications for 2023/24 were considered;

**Resolved** – Congresbury Youth Partnership application of £18,000 has been approved. Cllr Holland proposed and Cllr Underwood seconded.

**Resolved** – Congresbury Community Library application of £3,800 has been approved. Cllr Underwood proposed and Cllr Holland seconded.

**Resolved** – Congresbury Scouts and Guides application of £1000 has been approved. Cllr Holland proposed and Cllr Underwood seconded.



**Resolved** – Vision North Somerset application of £500 has been rejected. The Parish Council consider grant applications for this financial year should be allocated to the immediate locality of Congresbury. Cllr Underwood proposed and Cllr Holland seconded.

**Recommended** – Millennium Green Trust application has been suspended following further discussions at the next Millennium Green meeting, date to be confirmed. **Resolved** – The Millennium Green Trust application will be reconsidered at the next Finance meeting.

### 2137 Budget 2022/23

RFO provided Annual budget and report

**Recommended:** The Strawberry Line donation of £1000 has no allocated budget for payment. It is recommended to re-adjust the 2023/24 grant budget to accommodate expenditure by moving money from one budget heading to another. **Resolved** - Cllrs acknowledged this and agreed it was reasonable to move £1000 from Congresbury Youth Partnership (budgeted £19,540 grant approved £18,000) to accommodate this. Cllr Holland proposed and Cllr Underwood seconded

Annual Governance & Accountability Return (AGAR) 2021/22 **Resolved:** Cllrs noted the external audit for 2021/22 was completed by PKF Littlejohn LLP on 13<sup>th</sup> January 2023, and the Parish website was updated accordingly.

### 2139 Change of External Auditor

Smaller Authorities Audit Appointments (SAAA) has appointed new external auditor. **Resolved:** Cllrs noted the SAAA has appointed BDO LLP for the 5-year appointing period from 2022/23 until 2026/27.
